## Student Assistance Scheme (STAS) 2020

### ONE APPLICATION PER FAMILY

#### What is the Student Assistance Scheme?

The Student Assistance Scheme provides assistance for low income families towards the cost of levies. STAS is provided through school and college resourcing rather than payment direct to families. Catholic sector schools directly assess eligibility for assistance to families and queries for assistance need to be directed to the relevant school.

#### How do I know if I am eligible to apply?

Parents/guardians of students, or independent students, attending kindergarten to grade 12 in a Tasmanian State school or a registered non-government school can apply. Students who have previously completed year 12 should check with their school.

To be eligible you and your partner's combined/total gross taxable income must be no more than the figures shown in the income test table on page 2.

Catholic sector schools directly assess eligibility for assistance to families and queries for assistance need to be directed to the relevant school.

You must have a minimum 50% care of a child as deemed by Centrelink for them to be considered your dependent.

Grandparents raising children are eligible to apply for and receive STAS.

# Gross Taxable Income

<p><b>How can I prove our income and what will I need to provide?</b></p>	<p><b>You and your partner (if you have one) must be able to provide proof of your taxable income for the 2018 - 2019 financial year. Evidence of all income, including both Centrelink payments and any wages earned, needs to be supplied.</b></p> <p>Proof of all 2018-19 taxable income can be provided in the following ways:</p> <p><b>Centrelink Benefits</b> other than the Family Tax Benefit:</p> <ul style="list-style-type: none"> <li>• Your and your partner's Centrelink Customer Reference Number (CRN);</li> <li>• A copy of your Pension Card; or</li> <li>• A copy of your Health Care Card</li> </ul> <p><b>Earned Income</b> – attach a copy of your and your partner's:</p> <ul style="list-style-type: none"> <li>• 2019 Notice of Assessment from the Australian Taxation Office; or</li> <li>• Three recent, consecutive payslips</li> </ul> <p><b>Department of Veterans' Affairs</b> – (DVA) attach a copy of your and your partner's:</p> <ul style="list-style-type: none"> <li>• DVA Income Statement; or</li> <li>• DVA Pension Card</li> </ul> <p><b>Grandparents raising grandchildren</b> – must provide evidence of your formal relationship with the student(s) by providing:</p> <ul style="list-style-type: none"> <li>• Your Centrelink Customer Reference Number (CRN);</li> <li>• A copy of your Pension Card (with the student/s listed); or</li> <li>• A copy of your Health Care Card (with the student/s listed); or</li> <li>• A Statutory Declaration – available from a school or an Australia Post Office.</li> </ul>
<p><b>If I am an independent student under 18 how do I apply?</b></p>	<p>Independent students who are under 18 years of age and are submitting an application are required to provide proof of their independent status. Independent students are generally: supporting themselves; receiving a Centrelink payment and meet the Centrelink independence criteria. Proof of independent status can be in the form of a copy of a current Youth Allowance or ABSTUDY notice of assessment which must clearly indicate the student is independent. Alternatively, a suitable space has been included on the application form (page 3) for proof of independent status to be confirmed by Centrelink. Other acceptable evidence of independent status is a letter by a student counsellor or social worker. If independent status is not provided this will delay assessment of your application.</p>
<p><b>How will my application be assessed?</b></p>	<p>Your application will be assessed on the basis of either Centrelink payments (if that is your prime source of income) or your and your partner's (if you have one) total taxable income for the financial year ending 30 June 2019. Your information is subject to verification with the Australian Government Department of Human Services (Centrelink). If your or your partner's circumstances have changed since last financial year, your application will be assessed based on current circumstances and current income.</p>
<p><b>What terms and conditions need to be met for my application to be assessed?</b></p>	<ul style="list-style-type: none"> <li>• You (and your partner) have provided the information requested</li> <li>• You (and your partner) meet the Income Test for the Scheme</li> <li>• You (and your partner) have read and signed the Declaration and Authorisation on Page 4</li> <li>• <b>Applications need to be received prior to 4 September 2020.</b></li> </ul>
